

# **SCOPE**

Various stakeholders have pointed out the need to revise the rates due to the discrepancies in the prices indicated and the actual market prices of building materials and machinery. Therefore, a comprehensive review of the issued rates was carried out by the relevant institutions, namely the Provincial Engineering Services Department, the Provincial Irrigation Department, the Provincial Road Development Authority and the Kandy Municipal Council.

The impact of the following factors was considered.

- Increase in Value Added Tax (VAT) from 15% to 18%.
- Fluctuations of the Dollar value
- Relaxing of Import restrictions
- Other identified issues

Accordingly, price variations and their effects on the Rates of building materials and machinery were reviewed and revised as appropriate, and this is published as a supplement to the Schedules of Rates issued on  $1^{st}$  January 2024 with revised rates for the relevant items mentioned in the content page.
